The Collabor8 Provider Portal offers solutions to address gaps in care related to a patient's condition and quality of care, helping provider groups to code correctly and precisely, and to identify patients who require follow-up due to gaps in care or are at high risk.



Use Collabor8 to improve workflow, enhance cashflow, and reduce operational complexity and cost:

- Prioritize high risk, high value patients. Flexibly search, sort, and export lists of them to expedite scheduling.
- Monitor and manage the resolution of opportunities. View by type of gap, status, confidence, value, and more.
- Find patients lost to follow-up using Pulse8's last visit to PCP and last E&M visit to any provider for scheduling.
- Optimize face-to-face and telehealth consultations. View alerts in advance to plan, prioritize, and coordinate care, including morning huddles and before consult. Helps to validate potential missing codes or chronic conditions. Many providers print alerts to ensure they do not miss anything during the session.
- Improve risk scores by ensuring support staff are up to date on important coding guidelines. Pulse8 offers free webinars with AAPC CEUs, pithy one-pagers, short video tutorials, and other educational services.

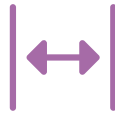
Persistent Conditions for Review

Risk-adjustable conditions that were verified by CMS during previous years but have not been confirmed this year. Includes important context like relevant diagnoses submitted by providers outside of your practice, last reported PCP encounter and level of clinical confidence.



Suspected Conditions for Review

Conditions inferred from clinical logic and data mining from the breadth and depth of data collected by the payer about your patients. Confidence scores inform providers of older and/or scant support that can signify new conditions, so they can prioritize their face-to-face assessments.



Quality Gaps in Care

Pharmacy Opportunities
